

## CAR-FREE AND SAFE ARRÁBIDA!

2020 BATHING SEASON  
13 JUNE TO 15 SEPTEMBER



The 'CAR-FREE AND SAFE ARRÁBIDA – Setúbal Beaches for All' programme, developed by the City Council, aims at solving a problem that has lingered for many years, by implementing a safe and sustainable mobility plan and a project to upgrade bathing areas.

Each year, over 350 thousand people visit the beaches of Arrábida, and the safety of those people comes first. Find out the reasons for a car-free Arrábida during this bathing season. There are real alternatives to allow everyone to enjoy our beaches.

The strategy includes the improvement of traffic conditions, by investing in public and soft modes of transportation and limiting the use of individual transportation, as well as a fight against irregular parking.

These measures are supported by the implementation of a set of interventions, which also cover the beaches, and a set of investments aimed at upgrading the bathing areas of Arrábida. The implementation of these measures is even more important this year, due to the need to comply with the exceptional and temporary scheme applicable to the occupation and use of beaches in the context of the Covid-19 pandemic, established by the Government for this bathing season. There is also a duty to comply with the provisions of Decree-Law no. 24/2020, of 25 May, entitled 'Stay Safe When Going to the Beach' - Be a Public Health Agent', to protect public health and guarantee safety conditions.

### • SECIL CAR PARK

Roofed parking for users of bus line 722  
N.º of places: 180 | Timetable: 8:00 a.m. – 8:00 p.m.

### • PRAIA DA FIGUEIRINHA

Unroofed parking | N.º of places: 230 | Timetable: 8:00 a.m. – 7:00 p.m.

### • CREIRO CAR PARK

### • PORTINHO DA ARRÁBIDA

Only residents, local economic activities and duly authorised situations are allowed to park at Portinho da Arrábida; you can only access the Creiro beach using the Creiro Car Park.

### • PRAIA DE ALBARQUEL

Parking is allowed only for local economic activities, people with disabilities signs and duly authorised situations, and access to the beach is allowed only by non-motorised or public transport.

### 'PRAIAS ARRÁBIDA' APP:

For an easier management of your trip, download the app **PRAIAS ARRÁBIDA** and see the number of available parking spaces at Figueirinha and Secil in real time.  
This application has no information on the remaining parking lots.

### 'INFOPRAIA' APP:

Before leaving home, please visit the INFOPRAIA APP in advance to check real-time availability at the beach you wish to visit, according to the colour system in place to indicate beach capacity.

## PUBLIC TRANSPORTATION TO THE BEACHES

### REGULAR BUS:

#### 723 • SETÚBAL (BUS STATION) • PRAIA DA FIGUEIRINHA

You can use your NAVEGANTE pass on this line  
On-board fare: 4.15 € – return ticket\*

#### 725 • SETÚBAL (ALEGRO SHOPPING CENTRE) • PRAIA DA FIGUEIRINHA

You can use your NAVEGANTE pass on this line  
On-board fare: 4.15 € – return ticket\*

#### 727 • BREJOS DE AZEITÃO • CREIRO

You can use your NAVEGANTE pass on this line  
On-board fare: 4.75 € – return ticket\*

### SHUTTLE:

(Not included in the Navegante Pass as it is a flexible shuttle service.)

#### 722 • SECIL CAR PARK • CREIRO (SHUTTLE)

Shuttle between the Secil Car Park and Creiro (stops at Figueirinha, Galapos, Galapinhos and Creiro).

On-board fare:

SECIL – FIGUEIRINHA: 1.00 € – return ticket

SECIL – GALAPOS – GALAPINHOS – CREIRO: 2.00 € – return ticket

FIGUEIRINHA – GALAPOS – GALAPINHOS – CREIRO: 1.00 € – return ticket

Frequency: every 15 minutes

#### 726 • SETÚBAL (CASA DA BAÍA, AV.ª LUÍSA TODI) • PRAIA DE ALBARQUEL

On-board fare: 1.40 € – return ticket

## SECTIONS WITH RESTRICTED ACCESS

There are three sections with restricted access, i.e. in which no individual means of transportation may circulate or park:

### 1 • FIGUEIRINHA – CREIRO SECTION

TIMETABLE: 8:00 a.m. – 8:00 p.m.

### 2 • ACCESS TO PORTINHO DA ARRÁBIDA

TIMETABLE: 8:00 a.m. – 7:00 p.m.

Access will be divided into two RCAAs – Restricted Car Access Areas:

- **RCAA 1** – between the intersection with the old EN379-1 and Casa do Gaiato;
- **RCAA 2** – between Casa do Gaiato and the Portinho car park (by the sea).

### 3 • ACCESS TO ALBARQUEL

TIMETABLE: 8:00 a.m. – 8:00 p.m.

THE RESTRICTIONS DO NOT APPLY TO THE FOLLOWING VEHICLES:

- Emergency and rescue;
- Security forces;
- Public transportation;
- Two-wheeled or four-wheeled motorised vehicles (they may park on the shoulders, as long they do not take up the road);
- Management entities with competence in the territory, when driving a properly identified vehicle: CMS, Capitania, Amarsul, Águas do Sado, ICNF, EDP, CME, IP, among others;
- Vehicles loading and unloading cargo, upon presentation of a valid Transportation Document;
- Taxis;
- Authorised TVDE (rideshare service) vehicles;
- Authorised tourist entertainment companies;
- Authorised transfer service companies;
- Public transportation vehicles in operation, when picking up and dropping off passengers;
- School transportation vehicles in operation, when picking up and dropping off passengers;
- Vehicles authorised by the Setúbal City Council.
