CAR-FREE AND SAFE ARRÁBIDA 2023 BATHING SEASON 3 JUNE TO 17 SEPTEMBER

The "CAR-FREE AND SAFE ARRÁBIDA" programme, developed by Setúbal City Council, aims to ensure safe and sustainable accessibility to the municipality's bathing areas, located in the Arrábida Natural Park.

Each year, over 350,000 people visit the beaches of Arrábida, and the safety of those people comes first.

The strategy includes the improvement of traffic conditions, by investing in public and soft modes of transportation and limiting the use of individual transportation, as well as a fight against irregular parking.

This year, for safety reasons due to the presence of a rock mass in danger of falling, the Figueirinha-Creiro section is off-limits, and the beaches of Galapos and Galapinhos cannot be reached through Figueirinha. The only possible access is via Creiro and from here, can only be reached on foot or by using the services of authorised vehicles.

PORTINHO DA ARRÁBIDA

Parking at Portinho da Arrábida is allowed only for residents, local economic activities and situations previously authorised, with access to Praia do Creiro via Creiro Car Park.

ALBAROUEL BEACH

Parking is allowed only for local economic activities, people with disability signs and duly authorised situations, and access to the beach is allowed only by non-motorised or public transport.

'PRAIAS DA ARRÁBIDA' APP:

For an easier management of your trip, download the app PRAIAS ARRÁBIDA on Google Play and see the number of available parking spaces at Figueirinha and Secil in real time.



For safety reasons, due to the presence of a rock mass in danger of collapse, the section between Figueirinha and Creiro is off-limits.

Access to the Galapos and Galapinhos beaches is not possible in the Figueira-Creiro direction, and is only possible via Creiro, on foot or using accredited vehicle services.

SECTIONS WITH RESTRICTED ACCESS

There are four sections with restricted road traffic, i.e., where individual transport is not allowed to circulate or park:

1 • ACCESS TO ALBARQUEL

RESTRICTED HOURS: 07 am - 08h pm

2 • ACCESS TO PORTINHO DA ARRÁBIDA

RESTRICTED HOURS: 07 am - 07h pm

The access will be divided in two RCAAs - Restricted Car Access Area:

- RCAA 1 between the intersection with the old EN379-1 and Casa do Gaiato:
- RCAA 2 between Casa do Gaiato and the Portinho car park (by the sea).

3 • ACCESS TO CREIRO BEACH

RESTRICTED HOURS: 07 am - 08h pm

For safety reasons due to the presence of a rock mass in danger of collapse, the Figueirinha-Creiro section is completely off-limits, with no access allowed. It is possible to access the beaches of Galapos and Galapinhos, via Creiro, on foot or using the services of authorised vehicles.

THE RESTRICTIONS DO NOT APPLY TO THE FOLLOWING VEHICLES:

- Emergency and rescue;
- Security forces:
- Public transport;
- Motor vehicles with two wheels or twin wheels (may park on verges, provided they do not occupy the roadway). It does not include sidecars or quad bikes;
- Management entities with competence in territory in vehicles duly identified: CMS, Port Authority, Amarsul, SMS, INCF, E-Redes, IP, among others:
- Loading and unloading attested by a Transport Document;
- Taxis:
- Authorised TVDE vehicles;
- Authorised tourist entertainment companies ;
- Authorised transfer companies*;
- Public transportation vehicles in operation, when picking up and dropping off passengers;
- Vehicles authorised by Setúbal City Council*
